    - i) approval of plans and specifications and authorization to advertise for bids;
  - b) Peek Road overpass and signalized intersection (2019-2020 CIP Project No. 1010), including:
    - i) authorization to proceed with the design of this project as a 4-lane overpass; and
    - ii) authorization to toll the Peek Road overpass;
  - c) Auxiliary lanes between Harlem Road and Mason Road, entrance and exit ramps at West Airport Boulevard, and U-turns at West Airport Boulevard (2019-2020 CIP Project Nos. 1002, 1004, and 1005), including:
    - i) authorization to combine these projects into a single Project No. 120.1002; and
    - ii) authorization to negotiate scope and fee for the design of Project No. 120.1002;
  - d) Addition of third lane between US-59 and Riverpark Drive (2019-2020 CIP Project No. 1003);
