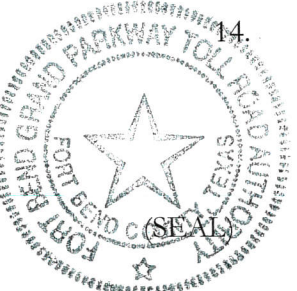
1. Receive public comments.
